With offices across Worcestershire, Shropshire and the West Midlands, we pride ourselves on ensuring our clients and people are right at the centre of everything we do.



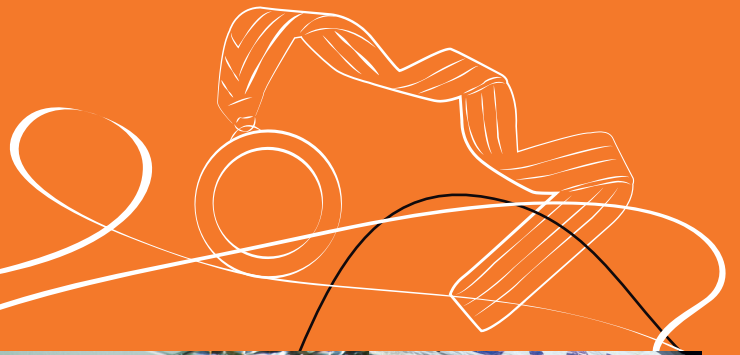
what does it mean to be a Trainee at mfg?

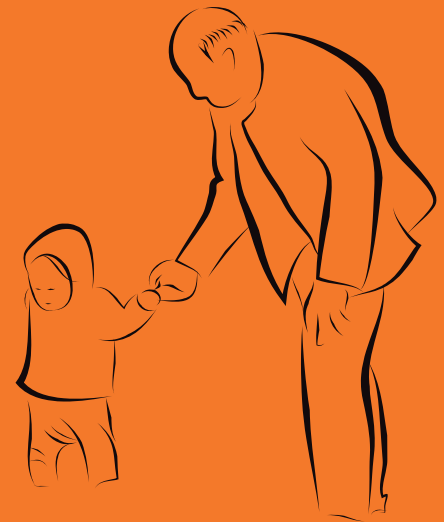

We know that as a Trainee it takes a while to understand what area of law you would like to be an expert in and we are able to offer a variety of options within our specialist teams.

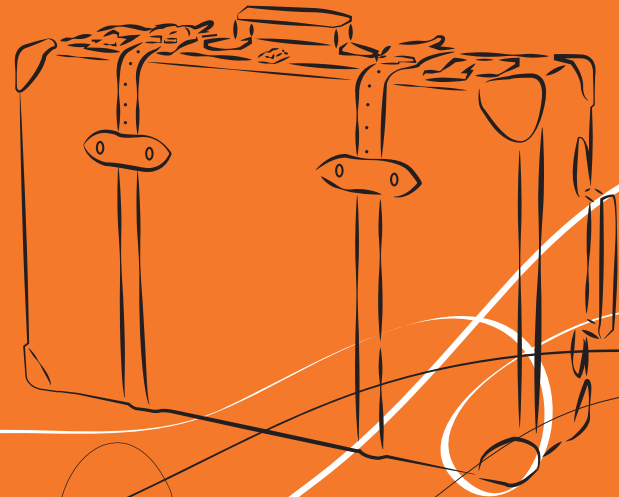
